ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, CONFEDERACAO BRASILEIRA DE VOLEIBOL (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. Withdrawing your consent
