

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, CONFEDERACAO BRASILEIRA DE VOLEIBOL (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**
